- List of customer contact details via an app
- Internet browser and device type
- Bank account number
- Special and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years old. Unless they have parental or guardian permission. For what purpose and on what basis we process personal data

CodingChiefs processes your personal data for the following purposes:

- Handling your payment
- Sending our newsletter and/or advertising brochure
- To be able to call or e-mail you if this is necessary to be able to carry out our services
- To inform you about changes to our services and products
- To offer you the opportunity to create an account
- To deliver goods and services to you
- CodingChiefs analyzes your behavior on the website in order to improve the website and to tailor the range of products and services to your preferences.
- CodingChiefs tracks your surfing behavior on various websites with which we tailor our products and services to your needs.
- CodingChiefs also processes personal data if we are legally obliged to do so, such as data that we need for our tax return.
- How long we keep personal data
- CodingChiefs does not store your personal data for longer than is strictly necessary to realize the purposes for which your data is collected. General
- personal data (first and last name, gender, date of birth, place of birth, address details, telephone number, e-mail address) are stored for a maximum of 2 years after conversion.

Personal data generated by cookies will be deleted as soon as you delete the cookies from your browser. This includes IP address, location data, data about your activities on our website, data about your surfing behavior across different websites and internet browser and device type.

Sharing personal data with third parties

CodingChiefs shares your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. We conclude a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. CodingChiefs remains responsible for these processing operations. In addition, CodingChiefs provides your personal data to other third parties. We only do this with your explicit permission.

Cookies, or similar techniques, that we use

CodingChiefs uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. CodingChiefs uses cookies with purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website

work properly and to optimize it. In addition, we place cookies that keep track of your surfing behavior so that we can offer customized content and advertisements. On your first visit to our website, we already informed you about these cookies and asked for permission to place them. View, modify or delete data

You have the right to view, correct or delete your personal data. You can do this yourself via the personal settings of your account. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This is to protect your privacy. CodingChiefs will respond to your request as soon as possible, but in any case within four weeks. CodingChiefs would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
